This letter and the enclosed document serves as the official Notification of Establishment Registration of the establishment which you listed on your Application for Establishment Registration (Form 3540-8 or Application) as being legally operated by Chryspac and requiring registration under Section 7 of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA). For each establishment listed on the Application, the U.S. Environmental Protection Agency has assigned a unique establishment registration number for that pesticide producing site. The establishment registration will remain in effect provided the required annual pesticide reports on pesticide production and sales and/or distribution volumes are submitted to EPA in accordance with the regulations promulgated pursuant to Section 7 of FIFRA. Please retain this Notification of Establishment Registration for your records as well as the copy of your Application with the registration assigned to your establishment.

Please note that a producer is defined in Title 40 of the Code of Federal Regulations (C.F.R.) Section § 167.3 as "any person who produces any pesticide, active ingredient, or device (including packaging, repackaging, labeling, and relabeling)."

If there are any changes in the information you provided on the Application (such as company name, address, ownership of the company, company official, authorized agent or any status of a registered establishment) these changes must be reported in writing, on company letterhead, within 30 days of the change(s) to this office.

Also enclosed is EPA Form 3540-16, Pesticide Report for Pesticide-Producing Establishments, and instructions for completing this form. 40 C.F.R. § 167.85(d) requires an initial report to be submitted to EPA, no later than 30 days after the original registration of each establishment.

Please complete EPA Form 3540-16 and return the <u>original</u> within 30 days of receipt of this Notice. These documents can be found at —

You should also keep a copy of the initial report for your records. It should be noted that failure to file this initial pesticide production report within 30 days and all subsequent annual reports on pesticide production may subject your company to civil penalties pursuant to Section 14 of FIFRA.
